Minutes of Proceedings
September 4th, 2012

The McPherson County Board of Commissioners met in regular session on Tuesday, October 2nd, 2012 in the Commissioners chambers. Chairman Dennis Wolff called the meeting to order at 9:00AM. Four County 4-H Agreement

Jeff Mueller presented the board with the agreement from the SDSU for the 4-H Advisor position between McPherson, Walworth, Edmunds, and Campbell counties. Jeff explained that the contract is the same as it was last year with the exception that the counties will now reimburse for cell phone usage. Neuharth moved and Feickert seconded to sign the contract for the next year. All voted in favor. Motion carried.

Joint Law Contract

The City of Eureka would like the commissioners to attend their next meeting on September 10th, 2012 to discuss the current joint law contract that they have with the county. Metzger and Neuharth will be attending this meeting.

Metzger moved and Neuharth seconded to request \$500.00 per month from May until September from the City of Leola to help offset the cost of the extra time and mileage the sheriff's office has been putting in with the City of Leola not having a police officer. All voted in favor. Motion carried. The Leola Police situation will be reviewed by the Board of Commissioners again in October.

Meeting Attendance Authorization
