RESOLUTION 10-14

RESOLUTION ESTABLISHING DRAINAGE REGULATIONS FOR MCPHERSON COUNTY, SOUTH DAKOTA, AND PROVIDING FOR THE ADMINISTRATION, ENFORCEMENT, AND AMENDMENT THEREOF, PURSUANT TO SDCL 46A-10A, 1985 AND AMENDMENTS THEREOF.

WHEREAS the McPherson County, South Dakota Board of County Commissioners, hereinafter referred to as the Board of County Commissioners, deems it necessary, for the purpose of promoting the health, safety, morals, and general welfare of the county to enact drainage regulations and to provide for its administration, and

WHEREAS the Board of County Commissioners, has appointed a County Drainage Commission, hereinafter referred to as the McPherson County Drainage Commission or Drainage Commission, to recommend appropriate regulations to be enforced therein, and

WHEREAS the McPherson County Drainage Commission has prepared regulations in accordance with the purpose to monitor by regulation, the drainage activity or obstruction of drainage within McPherson County and to provide an impartial forum for the resolution of landowner drainage disputes. And


WHEREAS the McPherson County Drainage Commission has given reasonable consideration, among other things, to the character of the districts and their peculiar suitability for particular uses, and

WHEREAS the Board of County Commissioners has given due public notice of the hearings relating to drainage regulations and restrictions, and has held such public hearings, and

WHEREAS all requirements of SDCL 46A-10A, 1985, with regard to the preparation of this regulation and subsequent action of the Board of County Commissioners has been met;

THEREFORE BE IT RESOLVED that the Drainage Permit Ordinance #10-1 of McPherson County, South Dakota is hereby adopted by the Board of County Commissioners, McPherson County, South Dakota.
