

RESOLUTION NUMBER 11-06

“RESOLUTION OF THE COUNTY OF McPHERSON, SOUTH DAKOTA  
ESTABLISHING LICENSE COSTS FOR TEMPORARY MALT BEVERAGE LICENSES  
AND TEMPORARY LIQUOR LICENSES PURSUANT TO SDCL, 35-4-124 & 125”

WHEREAS, pursuant to South Dakota Law, the County of McPherson, South Dakota, shall by resolution establish rules for regulating and restricting the issuance of special licenses for temporary malt beverage and temporary liquor licenses for special events and;

WHEREAS, the County of McPherson, South Dakota, wishes to comply with state law concerning operation of the special licenses;

NOW, THEREFORE, BE IT RESOLVED by the County of McPherson, South Dakota, as follows:

- A. A temporary malt beverage license and/or a temporary on-sale wine retailers license may be issued to a civic, charitable, educational, fraternal or veterans organization at a cost of \$25.00 per day per license. Temporary liquor licenses are not to be issued to such groups.
- B. A temporary malt beverage license and /or a temporary on-sale wine retailers license may be issued to any licensee holding a malt beverage license or on-sale alcoholic beverage license in the county or an organized municipality located within McPherson County at the cost of \$50.00 per day per license, and
- C. A temporary liquor license may be issued to any licensee holding a malt beverage or on-sale alcoholic beverage license in the county or an organized municipality within McPherson County at a cost of \$150.00 per day;
- D. A temporary off-sale package wine dealers license may be issued to a civic, charitable, educational, fraternal or veterans organization or to any licensee holding a malt beverage or on-sale alcoholic beverage license in the county or an organized municipality within McPherson County at a cost of \$150.00 per day.
- E. Each above-described license shall not exceed three consecutive days in length;
- F. That the licensee must comply with all applicable state laws concerning the consumption of alcoholic beverages as set for in SDCL CH. 35-4.

BE IT FURTHER RESOLVED by the County of McPherson, South Dakota as follows:

If the applicant already holds an on-sale alcoholic beverage license or a malt beverage license or if the license is to be used in a publicly owned facility, it is not necessary to have a hearing on the temporary application. The number of temporary licenses that may be issued to any licensee or organization in any calendar year is three (3).
