## Leola Hills State Radio Project

The South Dakota Bureau of Information and Telecommunications is considering installing a state radio communication system on the Leola Hills tower site. Sheriff Ackerman is working with the South Dakota Bureau of Information and Telecommunications on the possible installation details.

#### 2014 County Health Nurse Contract

### Ricardo Weisbeck Memorandum of Understanding

Neuharth moved and Feickert seconded sign the memorandum of understanding with Ricardo Weisbeck for the construction of a cold storage building in Eureka. All voted in favor. Motion carried.

## Annual Maintenance Agreement

Neuharth moved and Beilke seconded to charge \$100.00 per hour for grading and snow removal with a half hour minimum for all private parties and townships. All voted in favor. Motion carried.

## **Drainage Board**

Neuharth moved and Schumacher seconded to forego a drainage board meeting for the month of June due to no new drainage permits being submitted. All voted in favor. Motion carried.

## **Highway Department Matters**

Construction on the cold storage building in Eureka has started. The poles have been put in the ground and the remaining construction is in process.

Harry Hoff and Curtis Hoff approached the board about the county providing maintenance on the section line east of their farm. They stated that the road needs a little bit of gravel and blading. The Highway Superintendent agreed that he would be able to provide that amount of maintenance to that road.

The 2014 budget requests from the departments were given to the commissioners and budget review will begin next month. Becky Wolff updated the board on the sewer issues the courthouse had with the work that was done by Visu-Sewer.
