## **Executive Session**

Neuharth moved and Feickert seconded to go into executive session at 10:00AM to discuss indigent matters. All voted in favor. Motion carried.

Beilke moved and Schumacher seconded at 10:15AM to exit executive session. All voted in favor. Motion carried. No action was taken.

## Private Road Maintenance Agreement

Neuharth moved and Beilke seconded to charge \$100.00 per hour for grading and snow removal with a half hour minimum for all private parties and townships. All voted in favor. Motion carried.
