FEM Electric- permit to bore cable between Section 27 & 28 in T126N, R68. Valley Telco Communications- permit to bore cable in T126N, R73W.

SD DOT Easements

Feickert moved and Beilke seconded to approve easements to the SD DOT for Lot PE1, Lot PE2, and Lot PE3 in Block 2 of Original Town of Leola to install sidewalk and curb & gutter ramp. All voted in favor. Motion carried.

Highway Department Matters

Neuharth moved and Schumacher seconded to accept the 40 x 80 pole structure from Eureka City if offered to the county. All voted in favor. Motion carried.

An agreement has been prepared for Ricardo Weisbeck and the county for the pole structure that will be built. JP Lumber is requesting half of the cost of the materials before they submit the purchase order.

Two requests for additional approaches were discussed. The highway superintendent will look into adding approaches in the requested areas.
