Staci Ackerman from the SD Sheriff's Association came and discussed with the board the different bills that were discussed at the South Dakota Legislative summer session.

# Drainage Board:

At 10:30 AM Metzger moved and Feickert seconded to forego a drainage board meeting for the month of December due to no new drainage permits being submitted. All voted in favor. Motion carried.

#### Maintenance Department

Becky Wolff discussed her upcoming vacation in December. She has found someone to help temporarily with the janitor duties in her absence. The highway department will be completing the snow removal in her absence. She informed the board that her snow blower is no longer working the best. Metzger moved and Neuharth seconded to purchase a new snow blower. All voted in favor. Motion carried.

She discussed concerns about the water meter reading for the month of November. It is considerably higher than the previous month. She has checked and there is no apparent water leak. The meter will be monitored daily as well as contacting the City of Leola about installing a new meter.

#### Insurance Renewal

Metzger moved and Schumacher seconded to keep the employer contribution to health insurance at \$450.00 per month for a single plan for employee's who take the insurance offered through the county. Any amount above and beyond the \$450.00 for a single plan is the responsibility of the employee. The County will also not contribute to any spouse or children plans. The county will reimburse employees who have health insurance through another source at a rate of \$200.00 per month. This will be paid quarterly and proof of insurance must be turned into the Auditor's office for reimbursement. All voted in favor. Motion carried.

#### 2016 NECOG Agreement

Neuharth moved and Schumacher seconded to sign the 2016 agreement with NECOG. All voted in favor. Motion carried.

# Highway Department:

An issue that the Highway Superintendent has with some work that was done to an approach was discussed. The Auditor will call for 2016 fuel bids. These bids will be opened at the December 29<sup>th</sup>, 2015 meeting.
