RESOLUTION 15-2

"AUTHORIZATION TO CONSTRUCT ELECTRIC TRANSMISSON AND DISTRIBUTION LINES ON THE PUBLIC HIGHWAYS OF MCPHERSON COUNTY"

WHEREAS, East River Electric Power Cooperative, Inc., of Madison, South Dakota, on this 3rd day of February, 2015, filed with the County Auditor of McPherson County, South Dakota, its duly verified Petition for the purpose of obtaining and acquiring one franchise for both its existing transmission lines and system and the planned extension and future expansion thereof, from McPherson County, South Dakota, by and through its County Commissioners, for the right to maintain its existing and future system and to erect and maintain poles and wires for the purpose of transmitting and distributing electricity for lighting, heating, and power purposes, in, along, and over the public highways of McPherson County, South Dakota, for rural electrification throughout said County and State for a period of twenty years;

WHEREAS, said application was heard and considered by the members of the Board of County Commissioners of said County of McPherson, in South Dakota, on the 3rd day of February 2015, at the hour of 10 o'clock am., in the Commissioners' Room, in the City of Leola, McPherson County, South Dakota, due notice of said hearing having been given by mail as provided by law to all persons, firms or corporations owning or operating transmission, telegraph, or telephone lines on or along any part of the highways of said County;

WHEREAS, no person, firm or corporation having appeared in opposition to the granting of such application, and it appearing to the satisfaction of the Board of County Commissioners of said County that the request contained in said Petition should be granted;

THEREFORE, BE IT RESOLVED, by the McPherson County Board of Commissioners that the right to construct, maintain and operate poles and wires, both for its existing transmission lines and

system, and also for its future extension and expansion, for the purpose of transmitting and distributing electricity for lighting, heating and power purposes, over, upon, along and across the public highways within McPherson County, South Dakota, for rural electrician, on a county-wide basis, for a period of twenty (20) years from and after the date and passage hereof, be, and it hereby is, granted to said East River Electric Power Cooperative, Inc., of Madison, South Dakota, subject to the terms and conditions of Chapter 31-26 of the South Dakota Codified Laws (1984 Revisions).

Highway Department

Metzger moved and Feickert seconded to call for bids gravel crushing, reseal oil, and hot mix asphalt. All voted in favor. Motion carried.

The highway superintendent is working on creating applications for road access permits and also what guidelines the county needs for haul use agreements.

Neuharth moved and Feickert seconded to surplus scrap steel and cutting edges. All voted in favor. Motion carried.

Metzger moved and Schumacher seconded for all aircrafts to fill out an application with McPherson County to operate, take off, or land on any county highway. This application must be submitted at least one week prior to use. The applicant must agree to abide by subsections (2) and (3) of Section 70:02:02:08 of South Dakota administrative rule under the general authority of SDCL 50-2-2.1, that the aircraft shall be operated at their own risk, the county will assume no liability, proof of insurance must be provided and the aircraft operator must follow all Federal and State laws and regulations. Feickert moved and Metzger seconded to transfer \$18,801.70 from unorganized to county road and bridge. All voted in favor. Motion carried.

Window Replacement

Neuharth moved and Metzger seconded to accept the quote from house of glass for \$12,686.45 for first floor window replacement. All voted in favor. Motion carried.
