Highway Department

Neuharth moved and Metzger seconded to call for bids for reseal oil and hot mix asphalt. All voted in favor. Motion carried.

An ordinance for accommodations of utilities on county highway right-of-ways was discussed. The first reading of this ordinance will take place at the March meeting.

Spring load limits will take place soon. McPherson Counties load limits will go into effect the same time that Brown and Edmunds Counties limits go into effect.

Metzger moved and Schumacher seconded to enter into an agreement with the State of South Dakota to stripe approximately 41 miles of McPherson County roads at an estimated cost of \$44,206.20 to the county. All voted in favor. Motion carried.

An inventory of the signs was taken; a lot of the signs on hand are no longer up to state specifications. The highway department will re-face what they can and will be salvaging the rest.

The highway department employees will be attending a CPR and First Aid training in Eureka this month. Feickert moved and Metzger seconded to transfer \$42,449.38 from unorganized to county road and bridge for the 4th quarter of 2015. All voted in favor. Motion carried.

Meeting Authorizations

Neuharth moved and Schumacher seconded the following meeting authorizations: Jackie Rau to attend all SDSU 4-H Advisor events, 2 weed board members to attend the spring state weed board conference, and for Sheriff Ackerman to send a representative to the Police Chaplin training.
