There are currently no free tractor programs so he is working with C& B out of Roscoe to contract 3 tractors at \$12.00 per hour. He is still waiting for confirmation of availability. Spitzer will be sending 2 employee's to a chip spreader operation and troubleshooting class. Neharth moved and Beilke seconded to call for bids for hot mix, road oil, and gravel crushing. The bids will be opened at the March meeting. All voted in favor. Motion carried. Spitzer discussed the amount of salt sand that he purchased due to the ice storm that we had in December, we do have some reserve and it is currently being stored at the State salt shed. Neuharth moved and Beilke seconded to salvage all of the road signs that do not meet state regulations for reflectivity. All voted in favor. Motion carried. Metzger moved and Beilke seconded to surplus the 1971 TS14 scraper front s/n 55663 model

13UOT, rear s/n 22252 Model 81 SH, and a 2000 Freightliner Semi Tractor s/n 1FUJCPBAX1PH58829. Sealed bids will be called for on both items and will be opened at the March meeting. All voted in favor. Motion carried.

Sheriff Ackerman informed the board that some maintenance work is being done on the 2011 dodge pickup and that his new pickup has been ordered.

### Extension Department

Jackie Rau updated the board on her upcoming training as well as the projects and camps that she has planned for the summer.

### County Health Nurse

Jacalyn Eberhart gave a presentation to the board on the number of clients she is currently serving as well as her upcoming education classes.

# Maintenance Department

Becky Wolff informed the board of the lift being out of order and the anticipated timeframe in which it will be repaired. Fischer's Plumbing has come to fix the condensation pump on the boiler as well as remove a toilet and fix another toilet. Discussion was held on the building of a garage at the courthouse for storage as well as courthouse window updates.

Delmar Metzger will be attending the commissioner conference in March. Auditor Guthmiller informed the board that McPherson County will need to pick a chairman for the Upper Missouri River Valley for the upcoming term. A brief discussion was held on the recording of meetings, abatements that the Auditor's office is currently working on, and employee breaks. Deputy State's Attorney Hoffman gave the board a presentation on Robert's Rules of Order and the proper way to run a meeting. The 2016 end of year numbers were presented to the board.
