# Eureka Museum

Jean Bertsch and Barry Lapp requested an annual allocation from McPherson County for the purpose of helping run the Eureka Museum. The board will keep the request in mind for the upcoming 2017 budget.

## **Drainage Board**

Neuharth moved and Schumacher seconded to enter into drainage board at 10:30am. All voted in favor. Motion carried. A discussion was held on possible drainage litigation as well as a landowner dispute over a drainage project that was done before the drainage board was formed. No formal action was taken. At 10:40am Neuharth moved and Schumacher seconded to exit drainage board. All voted in favor. Motion carried.

## **Highway Department**

The highway Superintendent had a couple of part-time employee's help out for a few days due to some unexpected projects that needed to be taken care of right away. Feickert moved and Schumacher seconded to hire the part-time help of Doug Casey and Jared Neuharth. Feickert, Schumacher and Beilke voted in favor. Neuharth abstained from voting. Motion carried.

The highway superintendent gave the following report: he purchased a state truck for parts for \$6500.00 and plans to use the parts to repair an existing truck. He would like to purchase a new chip spreader in 2017. The activity has started on the pipeline he had a few minor issues with them but believes he has them all traveling the correct roads now. The main reseal for the year has been finished the only resealing that remains is patches and city work. Some asphalt repair will take place later in July. The bridge that was replaced by Nathan Hoffman's is complete and he believes this will be a long term fix. The highway department will be starting to work on culverts and other miscellaneous projects next week.

# **Right-Of-Way Permits**

Neuharth moved and Feickert seconded to approve the following right of way permits: Midco to plow fiber optics on 326<sup>th</sup> Ave, for FEM Electric to bore or blow power cable between Sections 11 & 14 and Sections 14 & 23 of 125-72, and for Valley Telco to bore fiber optics starting in Section 7 of 125-68 and boring west across 355<sup>th</sup> Ave into Section 12 of 125-69. All voted in favor. Motion carried.

## LeAnn Schwann

LeAnn Schwann requested the board to reduce or release a lien that McPherson County has against her residence in Leola. Neuharth moved and Feickert seconded that no lien reduction or release will be granted. All voted in favor. Motion carried.

# Meeting Date Change

Feickert moved and Schumacher seconded to move the July meeting from August 2nd to August 4<sup>th</sup>, 2016 at 9am due to Achievement Days. All voted in favor. Motion carried.

# **Executive Session**

Neuharth moved and Schumacher seconded to enter into executive session at 1pm with the 4-H Leaders, 4-H Advisor, Glenn Spitzer, and Kristi Spitzer present. All voted in favor. Motion carried.

At 1:55PM Neuharth moved and Feickert seconded to exit executive session. All voted in favor. No action was taken.

# **Fund Transfer**

Feickert moved and Schumacher seconded to transfer \$5,000.00 from the General Fund to the Emergency Management Fund. All voted in favor. Motion carried.

# 2017 Budget

The departmental requests for the 2017 budget were reviewed. Further discussion on the budget will take place at the August meeting.

## Part-Time Janitorial Help

Feickert moved and Neuharth seconded to hire Sharon Guthmiller to be the fill in part-time janitor at the rate of \$10.61 per hour. All voted in favor. Motion carried.
