OTHER MATTERS DISCUSSED AND ACTION TAKEN:

County Health Department

County Health Nurse, Jacalyn Eberhart, gave her quarterly report to the board. She discussed immunizations, WIC numbers, and activities for the upcoming months.

Grow SD

Maurine from Grow SD presented to the board the different programs that were offered to the residents of McPherson County and the number of residents who received each program in 2014 from Grow SD. She also explained how the allocation from McPherson County helps provide these services.

Drainage Board:

At 10:30 AM Metzger moved and Neuharth seconded to forego a drainage board meeting for the month of May due to lack of new permits being submitted. All voted in favor. Motion carried.

Highway Department:

Schumacher moved and Metzger seconded to approve a policy that sets forth the criteria for construction and maintenance of approaches accessing county/township roads, along with the permit fee amount for each type of approach. All voted in favor. Motion carried.

Glenn Spitzer will be having Doug Kinniburgh from local government assistance attend the next meeting to discuss with the board the new funds the highway will be receiving, the new legislation regarding wheel tax, and the Dakota access pipeline.

Discussion was held on the farming of the right of ways as well as markers that the highway department will be placing in the maintained right of ways. Discussion was held on the roads that will be resealed starting in June.

Executive Session

Neuharth moved and Feickert seconded to enter into executive session at 11:35PM for personnel issues. All voted in favor. Motion carried. At 12:10PM Metzger moved and Neuharth seconded to exit executive session. All voted in favor. Motion carried. No action was taken.

Mileage & Meal Reimbursement

Neuharth moved and Feickert seconded to follow the state rate changes for mileage and meal reimbursements that go into effect July 1st, 2015. Mileage reimbursement will be \$.042 per mile for use of a privately owned vehicle, covering all incidental expenses. If a privately owned vehicle is used when a county vehicle is available for use reimbursement will be \$.23 per mile. Meal reimbursements for in state will be \$6.00 for breakfast, \$11.00 for lunch, and \$15.00 for dinner, up to a maximum of \$32.00 per day, the state time schedule for computing meal allowances will be used. All voted in favor. Motion carried.

SDSU Memorandum of Understanding

Feickert moved and Schumacher seconded to sign the memorandum of understanding between SDSU and McPherson County. All voted in favor. Motion carried.

Sheriff Ackerman

Sheriff Ackerman approached the board with a proposal for adding a full time deputy sheriff. More discussion will be held on the addition of a full time deputy sheriff during the upcoming meetings. Feickert moved and Neuharth seconded for Sheriff Ackerman to obtain membership to the Mid-States Organized Crime Information Center (MOCIC). All voted in favor. Motion carried.

County Handbook Updates

The first two policies of an updated handbook were discussed. Further discussion on the remaining policies will continue at the June meeting.

Miscellaneous Items and Reports

A complaint received by the County Auditor from a taxpayer about back entrance parking was discussed with the board. The following items and reports were approved.
