#### OTHER MATTERS DISCUSSED AND ACTION TAKEN:

#### 4-H Advisor

Jackie Rau came before the board and discussed that we need to form a promotion and expansion committee for 4-H. She is looking for volunteers for the board and will submit a list of names to the board for approval before September.

#### **Sheriff Department**

Sheriff Ackerman introduced the new Deputy Sheriff, Steve Lipke, to the board. A discussion was held on the lack of 911 signs posted.

#### Abatement #16-6

Feickert moved and Metzger seconded to approve the abatement in the amount of \$29.90 for the Blewh Group/Eureka City. The land was transferred from Blewh Group to Eureka City in June of 2015 but was never recorded with the register of deeds. All voted in favor. Motion carried.

#### **Drainage Board**

Feickert moved and Schumacher seconded to enter into drainage board at 10:30am. All voted in favor. The only item that was discussed was lowering a culvert for Eric Odenbach, the highway superintendent will take care of it.

At 10:35AM Neuharth moved and Feickert seconded to exit drainage board. All voted in favor. Motion carried.

# **Zoning Board**

A concentrated animal permit application was discussed with the board. The county at this time does not have one. The Director of Equalization will gather information from other counties on what their process is and report back to the board at the June meeting.

#### **Highway Department**

A hearing was held on the maintenance of private roads. Neuharth moved and Schumacher seconded to charge \$100.00 per hour for grading and snow removal with a half hour minimum for all private parties and townships. All voted in favor. Motion carried.

The highway superintendent gave an update on the road work that has been completed and what else he has scheduled to complete. He also discussed the equipment he would like to upgrade.

Feickert moved and Schumacher seconded to transfer \$108,217.90 from unorganized to County road and bridge. All voted in favor. Motion carried.

#### **Right-Of-Way Permits**

Metzger moved and Neuharth seconded to approve the following right of way permits:

For FEM: to install a power cable in Section 33 of 126-67 and to install a power cable between Section 29 &30 of 125-71.

For Web Water: to bore a potable water line between Section 25 & 36 of 126-67

For Dakota Access Pipeline: to install pipeline between Section 18 & 19 of 125-73, to install pipeline between section 7 & 12 of 125-73 &74, to install pipeline between Section 7 & 18 of 125-73, to install pipeline between Section 19 & 20 of 125-73, to install pipeline in between Section 20 & 29 of 125-73, to install pipeline between Section 29 & 28 of 125-73, to install pipeline between Section 27 & 34 of 125-73, to install pipeline between Section 35 & 3 of 125-73 & 124-73. All voted in favor. Motion carried.

#### **Meeting Authorizations**

Metzger moved and Neuharth seconded the following meeting authorizations: The deputy auditor, deputy treasurer and deputy register of deeds to attend workshop in June and for Jennifer Guthmiller to attend budget training in July. All voted in favor. Motion carried.

Jennifer Guthmiller discussed with the board the enhanced crime coverage offered by SDPAA, Feickert moved and Metzger seconded to take the enhanced crime coverage offered by SDPAA. All voted in favor. Motion carried.

A possible water leak was discussed with the board. The janitor is to write down the water meter reading daily to keep track of the water usage. Jennifer discussed with the board about providing lunch for the election workers on Election Day. Neuharth moved and Schumacher seconded to provide lunch for the election workers.

A discussion was held on the commissioner #1 seat due to no petitions being submitted for the position.

# Miscellaneous Items and Reports

It was discussed by the board that it will be strictly enforced that all employees must take their lunch breaks as set forth by the handbook, no comp time will be given for working through lunch.
