The McPherson County Board of Commissioners met in regular session on Tuesday, May 2<sup>nd</sup>, 2017 in the Commissioners chambers. Chairman Feickert called the meeting to order at 10:00AM. Neuharth moved and Kunz seconded to approve the agenda of the May meeting and the minutes of the April 4<sup>th</sup>, 2017 and April 11<sup>th</sup>, 2017 meeting of the Board of Commissioners and Drainage Commission and the April 11<sup>th</sup>, 2017 minutes of the McPherson County Equalization Board. ## Drainage Board

At 10:30AM Beilke moved and Kunz seconded to forego a drainage board meeting for the month of May due to no new drainage permits submitted. All voted in favor. Motion carried.

## DemKota Beef Plant 5 Mile Manure Variance

A hearing was held on a 5 mile manure variance for DemKota Beef Plant. DemKota has requested a 5 mile variance for two different sites: TDO Farms Inc., and Spring Creek Colony. Present for the hearing were the following: Glenn Spitzer, Alvin Kallas, Richard Kolb, George Hulscher, Michelle Jung, Tom Thorpe, James Schaible, Dan Mettler, John Neifer, Dave Gienger, Jeff Mohr, Sam Wipf, Arden Sieh, Darvin Blumhardt, Keith Lunders, Larry Wolf, Jeff Vilhauer, Ken Vilhauer, Peggy Bieber, Daniel Dehaan, Alan Dunlavey, Dave Ackerman, and Susan Hoffman.

The first hearing was held on the 5 mile manure variance to haul to TDO Farms, Inc. located at 34656 121<sup>st</sup> St Hosmer, SD 57448. Previously, a variance was granted and it is set to expire on June 1<sup>st</sup>, 2017. Discussion was held with the surrounding landowners present at the meeting and they expressed their opposition to the continuation of the variance. Neuharth moved and Kunz seconded to deny a variance to DemKota Beef Plant to haul manure to TDO Farms after June 1<sup>st</sup>, 2017. All voted in favor. Motion carried. Also, it was discussed with DemKota that from now until June 1<sup>st</sup>, 2017 their drivers are to stay on the route that was approved with the highway supervisor at the variance hearing in November.

The second hearing was held on the 5 mile manure variance to haul to Spring Creek Colony located at 36562 102<sup>nd</sup> St Forbes, ND 58439. Discussion was held with the surrounding landowners present at the meeting. The only concern expressed was the possible damage that could be done to the roads. Neuharth moved and Metzger seconded to grant a variance to DemKota Beef Plant to haul to Spring Creek Colony until October 1<sup>st</sup>, 2017 under the following conditions: (1) DemKota must travel the route that was discussed and approved by the McPherson County Highway Superintendent and (2) approval must be obtained from Watcher and Weber Township in McPherson County and also from Brown County and Dickey County if the route approved includes any of their county roads. All voted in favor. Motion carried.

DemKota Beef Plant will be updating the commission monthly on their progress on finding another permanent site to dump their manure.

#### Grow SD

A representative from Grow SD came and discussed with the board how the money that McPherson County allocates to Grow SD is used to benefit the residents of McPherson County.

#### Dave Ackerman

Dave thanked the board for allowing him to purchase his new pickup. He also informed the board that the next LEPC meeting will be held on May 4<sup>th</sup> at 8pm in the Eureka Fire Hall.

# Permit to Occupy Right of Way

Neuharth moved and Beilke seconded to approve a permit to occupy right of way submitted FEM Electric to plow cable between sections 29 & 32 of 126-66. All voted in favor. Motion carried.

## Highway Department

Discussion was held on the mowing of the properties that McPherson County took by tax deed sale, the county will do their best to help with mowing the lots when time allows.

Discussion was held on the road maintenance currently happening within the county. The highway department is currently training some new operators on the motorgrader, there have been a few complaints but the issues are all being taken care of in the areas of concern.

Metzger moved and Beilke seconded for Glenn Spitzer to attend the summer highway superintendent meeting June 7<sup>th</sup> and June 8<sup>th</sup>. All voted in favor. Motion carried.

Neuharth moved and Metzger seconded for all of the highway department road crew employees to take a CPR and First Aid training class. All voted in favor. Motion carried.

Neuharth moved and Metzger seconded for Lindley Howard to be added to the approved signatures for CorTrust Bank checking account.
