The McPherson County Board of Commissioners met in regular session on Tuesday, March 7th, 2017 in the Commissioners chambers. Chairman Feickert called the meeting to order at 10:00AM. Neuharth moved and Kunz seconded to approve the agenda of the March meeting and the minutes of the February 7th, 2017 meeting of the Board of Commissioners and Drainage Commission. All voted in favor. Motion carried.

RESOLUTION 17-3

"BRIDGE INSPECTION PROGRAM RESOLUTION FOR SUE WITH SDDOT RETAINER CONTRACTS"

WHEREAS, Title 23, Section 151, United States Code and Title 23, Part 650, Subpart C, Code of Federal Regulations, requires initial inspection of all bridges and re-inspection at intervals not to exceed two years with the exception of reinforced concrete box culverts that meet specific criteria. These culverts are reinspected at intervals not to exceed four years.

THEREFORE, McPherson County is desirous of participating in the Bridge Inspection Program using Bridge Replacement funds.

The county requests SDDOT to hire Clark Engineering for the inspection work. SDDOT will secure federal approvals; make payments to the Consulting Engineer for inspection serviced rendered, and bill the County for 20% of the cost. The County will be responsible for the required 20% matching funds.

Drainage Board

At 10:30AM Neuharth moved and Kunz seconded to enter into the Drainage Board. All voted in favor. Motion carried. Their minutes are listed in a separate section.

Highway Department

Glenn discussed some complaints that he has had regarding the manure that New Angus has been hauling into Blaine Township. Gravel crushing has been postponed for the time being. A road by Boulder creek colony was discussed. The bridge on County road 1 is scheduled for June construction, and the bridge north of Wetonka needs to have the guard rails moved in; Glenn is obtaining quotes for the cost estimate of having the rails moved. Glenn informed the board that Perry Thompson has requested to step down as a motor grader operator and that Brandon Duquette will be taking over his territory. The date of the July commissioners

meeting was discussed as both Glenn and the highway secretary will be on vacation the week of the scheduled meeting. Neuharth moved and Beilke seconded to have the July meeting on July 6th due to the July 4th holiday falling on the regular scheduled meeting date. All voted in favor. Motion carried. A discussion was held between the County Auditor and Highway Superintendent regarding the plan of action for obtaining all the needed information from the highway department for the July meeting. Metzger moved and Beilke seconded for the highway department to send two employee's to the asphalt conference in April and for the highway superintendent to attend all requested meetings. All voted in favor. Motion carried. Neuharth moved and Kunz seconded to advertise for a mechanic welder/equipment operator for the highway department, this position will be out of the Leola shop. All voted in favor. Motion carried. A part-time job application that was submitted was also discussed. The Board of Commissioners will be having their annual road tour on March 17th.

2016 Annual Report

A copy of the 2016 Annual report prepared by the County Auditor was presented to the board.

Dave Ackerman- Emergency Management

Dave informed the board that Deputy Lipke has attended some Emergency Management training and has one more training session to attend to be up to the same level of training as him. Neuharth moved and Beilke seconded for Dave to purchase 3 hot spots, to purchase the salamander 02 track app solution and to apply for a grant for an additional speed sign for Leola. All voted in favor. Motion carried. Beilke moved and Metzger seconded to accept the resignation of Dawn Jenner and Kent Weiszhaar from the LEPC Board and to appoint Karl Moser. All voted in favor. Motion carried. The other vacant spot will be appointed after a nomination is received from the LEPC board.

Tax Abatement and Tax roll elimination

Neuharth moved and Kunz seconded to eliminate the following lots from the tax roll due to them being on the tax roll twice: Lots 7 through 12 Block 1 Original Plat Town of Hillsview Northside Addition Outlot L 8-125-72 40 acres and Outlot M 8-125-72 40 acres. All voted in favor. Motion carried.

Neuharth moved and Kunz seconded to abate taxes for 2016 pay 2017 for Record # 6753 and Record # 6754 for the county tax total of \$216.70 due to these being on the tax roll twice. Al voted in favor. Motion carried.
