The McPherson County Board of Commissioners met in regular session on Tuesday, November 7th, 2017 in the Commissioners chambers. Chairman Feickert called the meeting to order at 9:00AM. OTHER MATTERS DISCUSSED AND ACTION TAKEN:

Dave Ackerman

Sheriff Ackerman informed the board that engine needs to be replaced in the 2013 dodge pickup. Neuharth moved and Metzger seconded to have Aberdeen Chrysler replace the engine for the estimated cost of \$7500.00. All voted in favor. Motion carried.

Metzger moved and Beilke seconded for Sheriff Ackerman to purchase 3 tablets for the salamander app from the Emergency Management budget. All voted in favor. Motion carried.

Sheriff Ackerman plans to have some hazmat training in the county within the next year. There is a grant available to help cover the cost of the training. All local emergency services will be invited to participate in the training.

The Leola City Council has approved the retirement of their Chief of Police. This leaves the City of Leola without police. The City of Leola has had some discussions with Sheriff Ackerman regarding the county assisting with police control in the absence of them having a city police officer as well as their future plans for city police. The board told Sheriff Ackerman to have the Leola City Council get on the next meeting agenda to have a discussion on the matter.

The Leola school has approached Sheriff Ackerman regarding the possibility of having a DARE program next year. Sheriff Ackerman is looking into getting a certified officer for the program if the schools chose to add to their curriculum.

Kunz moved and Beilke seconded for the Sheriff and Auditor office to purchase a subscription for Aberdeen American News online to use for business purposes. All voted in favor. Motion carried.

The donation from Dakota Access Pipeline was discussed. Neuharth moved and Beilke seconded to sign the 2018 Walworth Jail Agreement. All voted in favor. Motion carried.

Drainage Board

At 10:30AM Neuharth moved and Kunz seconded to forego a drainage board meeting for the month of November due to no new drainage permits submitted. All voted in favor. Motion carried.

Wachter Township Maintenance Request

Mike Klipfel and Duane Klipfel came before the board to discuss the possibility of the county taking over 4 miles of maintenance on one of their organized township roads. The Klipfel's feel that the hutteriete traffic is what is causing all the damage and constant maintenance to that 4 miles. The board informed the Klipfel's that action was taken on this matter at the October meeting and at this time the board is not changing anything with the action that was taken.

Discussion also took place on a drainage matter in Wachter township. The board informed the Klipfel's that the matter they are referring to is a maintenance issue not a drainage issue and no permit is needed for the work.

County Health Nurse

Jacquelin Eberhart gave the board her quarterly update on the County Health program. She discussed with the board her low number of Leola clients and discussed the possibility of not coming to Leola as much. The board told her that they do not want the Leola hours decreased.

Holiday Closings

Belike moved and Kunz seconded to approve the following days Holiday days: November 23rd and November 24th in observance of the Thanksgiving holiday; December 25th and December 26th in observance of the Christmas holiday, and January 1st in Observance of New Year's Day. All voted in favor. Motion carried.

Health Insurance Renewal

Neuharth moved and Kunz seconded to accept the renewal quotes from Guardian dental and vision insurance and to reject the renewal quote from Wellmark for Health Insurance. All voted in favor. Motion carried. Loren and Mark from Mark Mehlhaff insurance presented Avera Health Insurance quotes to the board and employees. Neuharth moved and Kunz seconded to accept the Avera Health Insurance quotes; and as of 01/01/18 move all employees to Avera plans. All voted in favor. Motion carried. Mark and Loren will be enrolling employees in the new plans between November 27th and December 5th.

Holiday Open House

Beilke moved and Kunz seconded to have Christmas tree's set up in the lobby of the courthouse and to have an open house and tree judging on December 8th from 9am to 4pm. All voted in favor. Motion carried.

Highway Department

Glenn has had issues with trucks driving too fast on County road 17, he has addressed the issue with patrons. Neuharth moved and Kunz seconded to lease 3 tractors from C&B for \$15.00 per hour for a max of 250 hours. All voted in favor. Motion carried.

Neuharth moved and Kunz seconded to approve for the highway crew to work on holiday days November 9th and November 10th to finish up the Boulder Creek road. All voted in favor. Motion carried.

Neuharth moved and Beilke seconded to trade in the 2016 John Deere 644K Hybrid loader for the trade in value of \$199,600.00 and purchase a new 2018 John Deere 644K Hybrid loader for the purchase price of \$254,228.00. This bid is off of the Minnesota State bid. All voted in favor. Motion carried.

Discussion was held on the Capital I wing for a blade and on intentional damage that has been done to road signs. Glenn informed the board that the packer that the county had listed for sale on purple wave has sold for \$4800.00.

Neuharth moved and Beilke seconded to transfer \$181,312.21 from unorganized to county road and bridge. All voted in favor. Motion carried.

Right of way application

Neuharth moved and Beilke seconded to approve the right of way application submitted by FEM Electric to plow a 7200-volt line between sections 19 &30 of 125-72. All voted in favor. Motion carried.

Register of Deeds Appointment

Kunz moved and Neuharth seconded to appoint Vicki Geffre as Register of Deeds for the remainder of the register of deeds term which is until December 31st, 2018. The appointment is effective as of November 2nd, 2017 and the salary is \$3645.99 per month. All of Vicki's vacation and comp time earned prior to November 1st, 2017 will be paid out. Vicki can begin advertising for a Deputy for her office. All voted in favor. Motion carried.

Kunz Moved and Neuharth seconded to have John Hilgemann removed from the CorTrust Bank accounts and to add Vicki Geffre to all accounts. All voted in favor. Motion carried.

Miscellaneous Items and Reports

Kunz moved and Neuharth seconded to have the lights replaced in the Register of Deeds office, Treasurer's office and Director of Equalization office along with installing any needed outlets. All voted in favor. Motion carried.
