OTHER MATTERS DISCUSSED AND ACTION TAKEN:

Demkota Beef Plant

Patrons present for the discussion were: Glenn Spitzer, Lanette Butler, Tom Wipf, Aaron Wipf, Mr. Dunlavy and Mr. Dehaan. Discussion was held on the complaints that came before the board on the 5-mile manure variance that was granted to Demkota. No patrons were present to voice their concerns. Demkota informed the board that they do have 2 other sites approved to haul manure to and are hoping to have up at least one of them up and running in early spring. Demkota thanked the board for their generosity in working with them while they continue to get other manure hauling sites established. Discussion was also held on Demkota hauling up to Spring Creek Colony in early spring when the roads are soft. Demkota invited the Board of Commissioners to come and tour the plant.

Drainage Board

At 10:30AM Neuharth moved and Kunz seconded to forego a drainage board meeting for the month of December due to no new drainage permits submitted. All voted in favor. Motion carried.

Clark Engineering

Glenn Spitzer, Mike Gletuenkauf and Chelsey Sheridan were present for this discussion.

Mr. Gletuenkauf and Ms. Sheridan from Clark Engineering gave the board a presentation on the 2017 bridge inspections that were done in McPherson County.

City of Leola

Jackie Rau and Jessica Lipke from the Leola City Council and Sheriff Ackerman were present for the discussion. Leola City Council Representatives Rau and Lipke came before the board to discuss law enforcement needs for the City of Leola. Recently, the Leola City Police Chief resigned from his law enforcement duties and this leaves the City of Leola without law enforcement. Discussion was held on potential County Wide Law Enforcement as well as a potential Joint Law Contract with the City of Leola. After discussion Neuharth moved and Kunz seconded to negotiate a Joint Law Contract with the City of Leola for 30 hours per week of general law enforcement services with the approximate yearly cost being \$45,000. All voted in favor. Motion carried. The Leola City Police Chief officially resigned in early November, since that time the Sheriff's office has been providing law enforcement services to the City of Leola. Discussion was held on reimbursement on law enforcement services until a contract agreement has been made.

Discussion was also held on delinquent taxes on some property that the City of Leola had foreclosed on.

Sheriff Department

Kunz moved and Beilke seconded to sign the 2018 Edmunds County Jail Agreement as well as the Law Enforcement Mutual Aid Agreement with Edmunds County. All voted in favor. Motion carried. Discussion was held on the possible videoing of commission meetings. Discussion was held on a jail bill.

NECOG JCA Agreement

Metzger moved and Beilke seconded to sign the 2018 NECOG JCA Agreement. All voted in favor. Motion carried.

End of Year & January Meeting Dates

Beilke moved and Kunz seconded to have the year end meeting on December 27th at 2PM and to move the January meeting date to January 4th, 2018 at 10AM. All voted in favor. Motion carried.

Year End Balances

Auditor Guthmiller presented to the board the estimated year end balances and potential contingency transfers. Further discussion on year end numbers will take place at the December 27th meeting.

Highway Department

Glenn Spitzer was present for this discussion.

Glenn Spitzer informed the board that all of the gravel crushing has been completed, he also had Scepaniak do some reclaiming work also. Neuharth moved and Kunz seconded to purchase some salt sand from the SD Department of DOT. All voted in favor. Motion carried.

Glenn informed the board that instead of purchasing the John Deere 644K hybrid off of the Minnesota state bid he instead purchased it off of the EJPA bid.

Glenn informed the board that he has received the lift back but the motor has now gone out on it so he will have his guys repair it this winter

Discussion took place on the 4 miles of Wachter Township road that the township has requested assistance on maintenance on.

Beilke moved and Metzger seconded to call for fuel bids for 2018 at the December 27th meeting. All voted in favor. Motion carried.

Quit Claim Deed

Metzger moved and Neuharth seconded to quit claim deed Lots 5 and 6, Block One Hundred One, Braimer's Addition City of Eureka, McPherson County, South Dakota to Daryl Reiner. Daryl purchased the lot from McPherson County for \$250.00. This lot was advertised for sale at the tax deed sale, and did not sell at that time. All voted in favor. Motion carried.
