Metzger moved and Neuharth seconded to make the needed changes to the Income Guidelines in Appendix A to the current federal poverty level and to make no changes to Appendix B or Appendix C. All voted in favor. Motion carried.

Easter Holiday Closing

Neuharth moved and Beilke seconded to close the courthouse Friday, March 30th in observance of Good Friday. All voted in favor. Motion carried.

Eureka Community Healthcare Contract

Neuharth moved and Metzger seconded to approve the amended Eureka Community Healthcare Contract. All voted in favor. Motion carried.

Highway Department

Kunz moved Beilke seconded to approve Glenn to attend the Highway Superintendents short course in March. All voted in favor. Motion carried.

Neuharth moved and Beilke seconded to purchase two mowers from Premier Equipment in Bowdle for the purchase price of \$17,000.00 for each mower. All voted in favor. Motion carried.

State's Attorney Kallenberger discussed with the board and the Highway Superintendent the proper way to hire employee's and the importance of advertising and interviewing for all open positions.

Neuharth moved and Beilke seconded to hire Brandon Pickell as a seasonal highway employee at the rate of \$17.00 per hour. All voted in favor. Motion carried.

Neuharth moved and Beilke seconded to advertise for a full-time highway department employee out of the Leola shop. All voted in favor. Motion carried.

Neuharth moved and Beilke seconded to increase the salary of Rodney Malsam by \$.51 per hour now that he has completed his CDL and tank endorsements. All voted in favor. Motion carried.

Discussion was held on the selection of an engineering firm for the pavement signing project, the hydrology study that was completed at the Leola Dam, the waterline the City of Leola is proposing along County Road 19, large bills due to oil and filters, purchasing of a cage for the roller, road grinding, and the road tour that the Board of Commissioners took on February 13th. No action was taken on any of the matters.
