# McPherson County Board of Commissioners Minutes of Proceedings December 28th, 2018

The McPherson County Board of Commissioners met in session on Friday, December 28th, 2018 in the Commissioners chambers. Chairman Feickert called the meeting to order at 10AM. Members present were: Jeffrey Neuharth, Anthony Kunz and Rick Beilke. Absent: Delmar Metzger. Also present was Glenn Spitzer.

Neuharth moved and Kunz seconded to approve the minutes from the December 4<sup>th</sup>, 2018 Board of Commissioners and December Drainage meetings. All voted in favor. Motion carried.

### **Courthouse Closing**

Neuharth moved and Kunz seconded for the McPherson County Courthouse to close at 12PM on January 18th. All voted in favor. Motion carried.

# **DOE Office**

Lanette Butler spoke with the board about an upcoming senate bill that would make implementation of GIS mandatory. McPherson County is one of the 11 counties who do not have GIS in place. Approximate costs, timelines and options available from different companies were discussed. GIS would be necessary prior to making a software switch from ULTRA to Vanguard or considering a full county appraisal. Other needs/updates to the DOE office were also discussed.

## Highway/Sheriff Department

Both Spitzer and Ackerman discussed with the board department purchases/needs for 2019.

### Budget, Fund Transfer, End of Year Balances and General Fund Assignment

McPherson County received approval from the Dept. of Revenue for the 2019 budget and 2018 pay 2019 tax levies.

Year End estimates for all funds were examined. After reviewing the end of year numbers Neuharth moved and Kunz seconded to approve the following transfers \$168.97 from the General Fund to E911, \$20,000 from the General Fund to Emergency Management, and \$8,000 from General Fund to Leola Joint Law. All voted in favor. Motion carried.

Kunz moved and Neuharth seconded to unassigned \$50,000 in the general fund assigned for the Law Enforcement purposes and to assign \$300,000.00 for Director of Equalization Updates. All voted in favor. Motion carried. Total assigned amounts in the general fund as of December 28<sup>th</sup>, 2018 are as follows: \$189,000 Courthouse Repairs, \$100,000 Law Enforcement Purposes, \$320,000 Road & Bridge, and \$300,000 Director of Equalization Updates.

Kunz moved and Neuharth seconded to purchase a 2019 Dodge Ram pickup for the Sheriff Department. All voted in favor. Motion carried.

Neuharth moved and Beilke seconded to purchase a 2019 Dodge Ram pickup from state bid for courthouse use and to surplus the 2004 Dodge Caravan (VIN#1D4GP24R34B527669) in 2019. All voted in favor. Motion Carried.

# **Executive Session**

Neuharth moved and Kunz seconded to enter executive session at 1:44PM to discuss employee raises. All voted in favor. Motion carried. Kunz moved and Neuharth seconded to exit executive session at 2:23PM. All voted in favor. Motion carried. No action taken.

### **Abatements**

Kunz moved and Beilke seconded to approve the following abatements that were a result of the 2017 tax deed sale:
