McPherson County Board of Commissioners Minutes of Proceedings January 8th, 2019

The McPherson County Board of Commissioners met in regular session on Tuesday, January 8th, 2019 in the Commissioners chambers. Chairman Feickert called the meeting to order at 10:05AM. Members present were Rick Beilke, Jeff Neuharth, Sid Feickert, and Anthony Kunz. Also present: Austin Hoffman, Glenn Spitzer, Rick Rau and Lanette Butler.

Feickert relinquished the Chair to the Auditor for the purpose of reorganizing the board for the year 2019. Nominations for chairman were requested. Feickert nominated Neuharth for chairman. Kunz moved and Metzger seconded that nominations cease and that a unanimous ballot be cast for Neuharth. All voted in favor. Motion carried.

Nominations for vice-chairman were requested. Neuharth nominated Kunz for vice-chairman. Beilke moved and Feickert seconded that nominations cease and that a unanimous ballot be cast for Kunz. All voted in favor. Motion carried.

The Auditor relinquished the Chair to Chairman Neuharth.

RESOLUTIONS:

RESOLUTION 19-1 "RESOLUTION IMPOSING SPEED LIMITS AND WEIGHT PER AXLE LIMITS"

WHEREAS, the County of McPherson, South Dakota, is responsible for the maintenance of certain highways under its jurisdiction, and

WHEREAS, it appears said highways, by reason of deterioration, rain, snow or other climatic conditions will be seriously damaged or destroyed unless the use of vehicles thereon is prohibited or restriction as to the weight of vehicles are imposed

NOW THEREFORE, BE IT RESOLVED: Pursuant to SDCL 32-14-6 and any laws amendatory, thereto, that the load limits on all McPherson County oil roads be posted at 6 ton per axle. McPherson County oil roads will be posted at 40 mph for trucks.

BE IT FURTHER RESOLVED: That there shall be erected and maintained signs designating the provision of this resolution as provided by state law, and that this resolution shall not be effective until or unless such signs are erected and maintained.

BE IT FURTHER RESOLVED: That the County of McPherson shall request the South Dakota Highway Patrol to enter the County of McPherson to ensure compliance with State Laws pertaining to vehicle weight and with the weight laws established by this resolution.

BE IT FURTHER RESOLVED: That the speed limit for trucks on all county oil roads within McPherson County, South Dakota, shall be 40 MPH. McPherson County requests South Dakota Highway Patrol to enter the County of McPherson to enforce the speed limit of 40 MPH for trucks on all McPherson County oil roads.

BE IT FURTHER RESOLVED: That the effective dates of the provisions of this resolution shall start the same time that the State of South Dakota starts their restrictions and shall end 1 week after the State lifts their limits.

Extension Memorandum of Understanding

Feickert moved and Kunz seconded to sign the 2019 Extension memorandum of understanding with South Dakota State University. All voted in favor. Motion carried.

<u>Highway Department</u>

Spitzer presented an estimate from Fischer Painting and Drywall for painting the shop buildings in Eureka. A decision on painting was tabled until spring.

Beilke moved and Metzger seconded to declare some scrap steel and aluminum as surplus property. All voted in favor. Motion carried.

Spitzer along with Rick Rau discussed what they would like for step pay and annual raise increases for the highway department in 2019.

Equipment needs in 2019 and the possible surplus of a semi and dozer were discussed. No action taken.

Feickert moved and Metzger seconded to have Curt Schumacher, Stanton Spitzer, Jack Geffre, Lee Geffre, Perry Thompson and Doug Casey as part-time help as needed at the rate of pay of \$18.76 per hour. All voted in favor. Motion carried.

Feickert moved and Kunz seconded to transfer \$83,346.84 from unorganized to county road and bridge. All voted in favor. Motion carried.

<u>2019 Raises</u>

Feickert moved and Kunz seconded to give all courthouse employees except the Commissioners a 1.5% raise + \$500/year, the Veteran Service Officers a 3% raise and the hourly highway

personnel a \$0.52/hour cost of living raise plus step pay increases as determined by the highway superintendent; effective January 1st, 2019. All voted in favor. Motion carried.

Drainage Board

At 10:30AM Feickert moved and Kunz seconded to meet as the McPherson County Drainage Commission. All voted in favor. Motion carried. The commission met concurrently with the Board of Commissioners and their minutes are listed in a separate section.

Meeting Authorizations

Beilke moved and Kunz seconded for Vicki Geffre to attend the Deed Magic workshop on January 24th in Watertown. All voted in favor. Motion carried.

2018 Year End Balances

Auditor Howard discussed the year end balances with the board.

Employee Handbook

Current vacation/sick/personal and comp time were discussed along with implementing yearly roll over limits on comp time. More discussion will be held at the next meeting.

Director of Equalization

Butler presented a contract from District III for Geographic Information System (GIS) Metzger moved and Beilke seconded to sign the contract with District III with fees of \$51,000 and follow the presented 3-year payment option with the first payment due in January 2020. All voted in favor. Motion carried.

Representatives from the Eureka and Leola Schools met with the board. They discussed the State Aid formula and what impact a full county assessment would have on their funding. Increases in district property valuation may not increase their total dollars; instead it would increase the local burden and decrease state aid dollars with total general fund dollars remaining essentially the same. Capital Outlay and Special Ed funds were also discussed as well as other aspects/regulations surrounding the state aid formula and the effects of a school being privately funded versus accepting state aid.

Executive Session

Feickert moved and Kunz seconded to go into executive session at 2:18PM to discuss a pending lawsuit. All voted in favor. Motion carried. Kunz moved and Feickert seconded to exit executive session at 2:26PM. All voted in favor. Motion carried. No action taken.

Safety Benefits Recommendations:

Jeff Lanning with Safety Benefits conducted a loss control visit to McPherson County in August of 2018. Recommendations from that visit were presented. More discussion will be held on the recommendations at the next meeting.

Sheriff Department

Metzger moved and Beilke seconded to sign the 2019 Edmunds County and Faulk County Jail Agreements. All voted in favor. Motion carried.

An update on the progress of the PDM Plan update was given. An attendance sheet for those present during the update is on file in the Auditor's Office.

Miscellaneous Items and Reports

Kunz moved and Beilke seconded to add Holly Mueller to the Leola EMT roster. All voted in favor. Motion carried.

The following miscellaneous items and reports were reviewed and approved: The 2018 property inventory, Veteran Service Officers quarterly and yearly reports; Register of Deeds statement of fees collected during the month of December 2018 for the amount of \$2351.00, Register of Deed's Modernization and Preservation fees collected during month of December 2018 for the amount of \$108.00, Auditor's Account with the County Treasurer as of December 31st, 2018 as follows: total amount of deposits in Leola Bank, \$95,742.02; total amount of actual cash, \$610.00; total amount of checks and drafts in treasurer's possession not exceeding three days, \$17,930.12; CD's, \$1,151,055.56; Super savings, \$1,303,692.63; total, \$2,569,030.33.
