McPherson County Board of Commissioners Minutes of Proceedings March 6th, 2019

The McPherson County Board of Commissioners met in regular session on Wednesday, March 6th, 2019 in the Commissioners chambers. Chairman Neuharth called the meeting to order at 10:00AM. Good Friday Closing

Kunz moved and Beilke seconded for McPherson County to be closed on April 19th in observance of Good Friday. All voted in favor. Motion carried.

Becky Wolff

Becky Wolff informed the board that the courthouse boiler pumps and float need to be replaced. An estimate from G&R Controls was presented, the board informed Wolff to go ahead with the replacement. G&R Controls also looked at several registers while they were here and recommended that an automatic chemical pump is installed. The board informed Wolff to get a quote to fix the registers and for the automatic chemical pump.

Drainage Board

At 10:30AM Metzger moved and Kunz seconded to meet as the McPherson County Drainage Commission. All voted in favor. Motion carried. The commission met concurrently with the Board of Commissioners and their minutes are listed in a separate section.

Director of Equalization

Assessments were sent out to all county property owners. There will be a few appeals. Butler updated the board on Vanguard Appraisal's answers to several questions that were asked at the last meeting. The board had a few more questions for Vanguard before making a final decision to switch software. Butler would like to see a focus on reappraisal particularly in the towns. To do that an additional employee is needed in the DOE office. Kunz moved and Metzger seconded to advertise for a Deputy Assessor. All voted in favor. Motion carried.

State's Attorney

A few juror chairs in the courtroom are broken and not safe. The Auditor will purchase five replacement chairs.

Surplus Property Auction

At 11AM a live auction of surplus property was held in the Commission Chambers. An opening bid of \$1500.00 from H.F. Jacobs for the 12ft Balderson Snow Wing was presented. Beilke move and Kunz seconded to accept the bid. All voted in favor. Motion carried.

Highway Department

Kunz moved and Beilke seconded to advertise for a fulltime highway mechanic/machine operator. All voted in favor. Motion carried.

Spitzer updated the board on road conditions and the status of snow removal. There are numerous spots around the county that are impassable and proving extremely challenging to keep open. Options for challenging locations were discussed including bulldozer rental, and talking with landowners about proper snow piling locations. Costs associated with snow removal and equipment operators/wear/repairs were also discussed.

Right of Way Permits

Beilke moved and Kunz seconded to approve the following right of way permits: WEB Water to bore a potable water line in Section 27 of T126N-R68W, FEM to plow power cable in Section 29 in T127N-R67W and FEM to bore power cable between Sections 2 &11 of T128N-R71W. All voted in favor. Motion carried.

Emergency Management

Kunz moved and Metzger seconded to purchase the suggested additional 10,000 sandbags off of the state bid. All voted in favor. Motion carried.

Auditor's Office

Candidates for the open Deputy Auditor position were discussed.
