OTHER MATTERS DISCUSSED AND ACTION TAKEN:

Health Insurance Renewal

Lorne Serr from Mark Mehlhaff Insurance presented the 2020 premium quotes from Avera and Wellmark for health insurance.

Feickert moved and Kunz seconded to accept the renewal quotes from Avera Health, offer the Avera 4000, Avera 5500HDHP and Avera 6000 in 2020 and to keep the county's contribution toward health insurance the same. All voted in favor. Motion carried.

Mark and Lorne will be re-enrolling employees in the new plans on December 3rd.

Walworth County Jail

Discussion was held on the Walworth County Jail and the concerns the commissioners have with the project. Metzger will represent McPherson county on the regional commissioner's board, he will express McPherson County's concerns and attend the Walworth County Commissioners meeting on November 19th.

Sheriff's Department

Sheriff Dave Ackerman presented a quote for Leads Online a web-based tool his office could utilize in investigations. Discussion will continue at the next meeting.

Public Concerns

Feickert and Beilke brought up concerns voiced to them about excessive speed and traffic not stopping at the stop sign on County Road 21. Sheriff Ackerman will increase presence in the areas of concern and a resolution to lower the speed limit on that road may be considered in the future.

Ken Stugelmayer shared concerns about the valuation and taxes on one of his parcels of land and land access concerns to another parcel.

Drainage Board

At 10:45AM Kunz moved and Metzger seconded to meet as the McPherson County Drainage Commission. All voted in favor. Motion carried. The commission met concurrently with the Board of Commissioners and their minutes are listed in a separate section.

Highway Department

Feickert moved and Beilke seconded to call for sealed bids for the 1998 International Truck VIN#1HTGCADR3WH538287 and the 2000 International Truck VIN#1HTGCADT1YH309184 to be opened on December 3rd at 11AM. All voted in favor. Motion carried.

Spitzer updated the board on equipment, department needs, and the FEMA reimbursement status. The 2019 highway budget was discussed. Culvert projects and road conditions were discussed along with future projects for 2020.

Right of Way Permits

Metzger moved and Kunz seconded to approve the following right of way permit: Wesley Schaible, to bore and underground water line between Section 26 and Section 35 of 125-71. All voted in favor. Motion carried.

Planning and Zoning Ordinance

McPherson County is in the process of rewriting the planning and zoning ordinance, and changes have been authorized for Section 23, Concentrated Animal Feeding Operations and Regulations. Kunz moved and Beilke seconded to not accept any new CAFO permit applications until the updated ordinance has been adopted. All voted in favor. Motion carried.

Director of Equalization

Lanette Butler shared with the board that Deputy Assessor Jackie Kessler has passed her CAA test and is certified. The Vanguard system is installed and the office has begun to use the program. Butler updated the board on the most recent AgTaskforce meeting.

Veterans Service Officer

The board has been informed of VSO Harvey Schaible's intent to not seek reappointment come January 1st, 2020. Kunz moved and Feickert seconded to combine the two current VSO positions into a single position and to advertise the new position for 2 weeks. All voted in favor. Motion carried.

Auditor's Office

2020 levies have been submitted to the Department of Revenue. The 2019 budget, transfers and end of year cash on hand estimate was discussed. More discussion will continue at the December meeting.

Pre-Disaster Mitigation Planning Meeting – NECOG

A mitigation planning meeting was held at the County Courthouse on October 24th with representatives from Eureka City, Leola City and McPherson County present. An update from the meeting, prepared by NECOG, was read to the board.

Becky Wolff

Becky Wolff updated the board on the progress the boiler repairman has made on replacing parts within the heating registers around the courthouse. Wolff also informed the board that the large window on the 3rd floor leaks in certain weather conditions and will need to be replaced.

Holiday Closing and Holiday Open House

Metzger moved and Beilke seconded for the McPherson County Courthouse to be closed on November 29th, December 23rd and December 24th. All voted in favor. Motion carried. Feickert moved and Kunz seconded to allow Christmas trees from area groups to be displayed at the courthouse for the holiday season and to have a holiday open house with Christmas tree judging on December 6th. All voted in favor. Motion carried.
