## <u>Demkota Permit excerpt from – September 2021</u>

Demkota representatives Dan DeHaan and Adam Bode joined the meeting along with Sam Wipf. A secondary site for solid manure has been taking most of the loads with the centrifuge system operational and load numbers have decreased over the last two months. The permit fees for June-August have not been received. This issue will be addressed by Demkota.

Neuharth moved and Metzger seconded to extend the 5-mile manure variance permit that was granted to DemKota Beef Plant at the May 2021 meeting until March 1st, 2022, with the price per load staying at \$200/load; a rate reduction will be considered in February if load counts stay consistently low. The following conditions will continue: (1) To lessen road wear DemKota will travel the original route - hwy 10, north on C23, west on C2 and south on C21 to location for approximately 50% of the loads, the other 50% of the load will be hauled on the alternative route - enter McPherson County going west on C2, south on C21 to location, (2) approval must be obtained from Wachter and Weber Townships in McPherson County and also from Brown County and Dickey County if the approved route and/or alternate route includes any of their county roads. All voted in favor. Motion carried.

### Boiler Concerns – Scott Hansel from G&R Controls came on 1/18 to fix registers not working on 3<sup>rd</sup> floor

- Checked on water softener since Scott discovered it was backwards in fall 2020. Softener was still hooked wrong and wasn't programed.
- Scott asked about the chemical pump on 1/18 Kalen reported no problems.
- Chris (chemical guy with G&R Controls) received a phone call from Kalen after Scott had left the courthouse asking how to program the chemical pump. Chris called Scott concerned about the water quality. Scott came back on 1/19 took a water sample. Water tested very hard. Scott doesn't believe any chemical has been used most of last year. More detailed report to come.
- While Scott was here on 1/19 he switched the lines around for the water softener and programed it, it's currently running correctly. The softener has a memory feature so it shouldn't have to be reset unless it's unplugged or a long power outage.
- Also mentioned that Kalen should not drain the boilers by himself this year. It caused some problems for the servicemen last year.
- Only weekend work needed with the boilers would be to check on them after a long power outage where the generator didn't kick in.
