## **Comp Time on Weather days**

No employees have earned comp time (or had to use any time off) for weather days when the courthouse is closed. Several employees were available on weather days for calls transferred from the office phones to their personal cells and/or working from home. Currently if the courthouse is open and the employee cannot come to work or cannot work a full day those employees use time off to make up unworked hours.

Auditor is suggesting that we continue the above policy and reiterate it with a motion in the minutes stating:

- When the courthouse is closed courthouse employees will be paid for a normal day. Employees who report to work when the courthouse is closed for weather or work from home will only earn comp time if they work more than their regularly scheduled hours.

Or if the commission doesn't want to continue the above policy the other option I would suggest is:

- When the courthouse is closed due to weather employees are required to use vacation time or take an unpaid day off. Hours worked either remotely or hours worked at the courthouse on weather days will reduce the number of leave hours the employee needs to take to equal their regularly scheduled hours for the weather day.

# **Clerk of Courts**

As of 3/29/2023 the Law Library Cash Balance is \$580.13. Per Ronda Jim would buy supplies out of this fund and build the shelf during courthouse time so there would be no additional labor costs.
